On November 3, 2017, an evaluation committee representing Kimley-Horn & Associates, Inc., Trinity River Authority, and various City Department staff convened, reviewed, and evaluated the submitted proposals based on the evaluation criteria set forth by the competitive sealed proposal method of procurement. Evaluation criteria included proposed contract price, experience of the proposer with similar projects, experience and qualifications of key personnel, past experience with the owner, schedule reduction, cost savings, and subcontractors. It was determined by City staff that the alternates included in the proposal form would not to be utilized for construction and therefore not considered as part of this evaluation. Based on the committee rankings provided above of the aforementioned criteria, Tiseo Paving Co. received the highest total average ranking score.

We contacted the following references for Tiseo Paving Co. and received favorable reviews for the work they performed and/or are currently performing for these entities on similar type projects. Most responded that Tiseo Paving Co. is a reputable contractor performing high quality work.

During subsequent proposal negotiations with the City, Tiseo Paving Co. agreed to reduce its bid price to \$ 12,688,471.60 and schedule from 750 to 700 Calendar days. Details of these price negotiations can be found in Attachment B.
