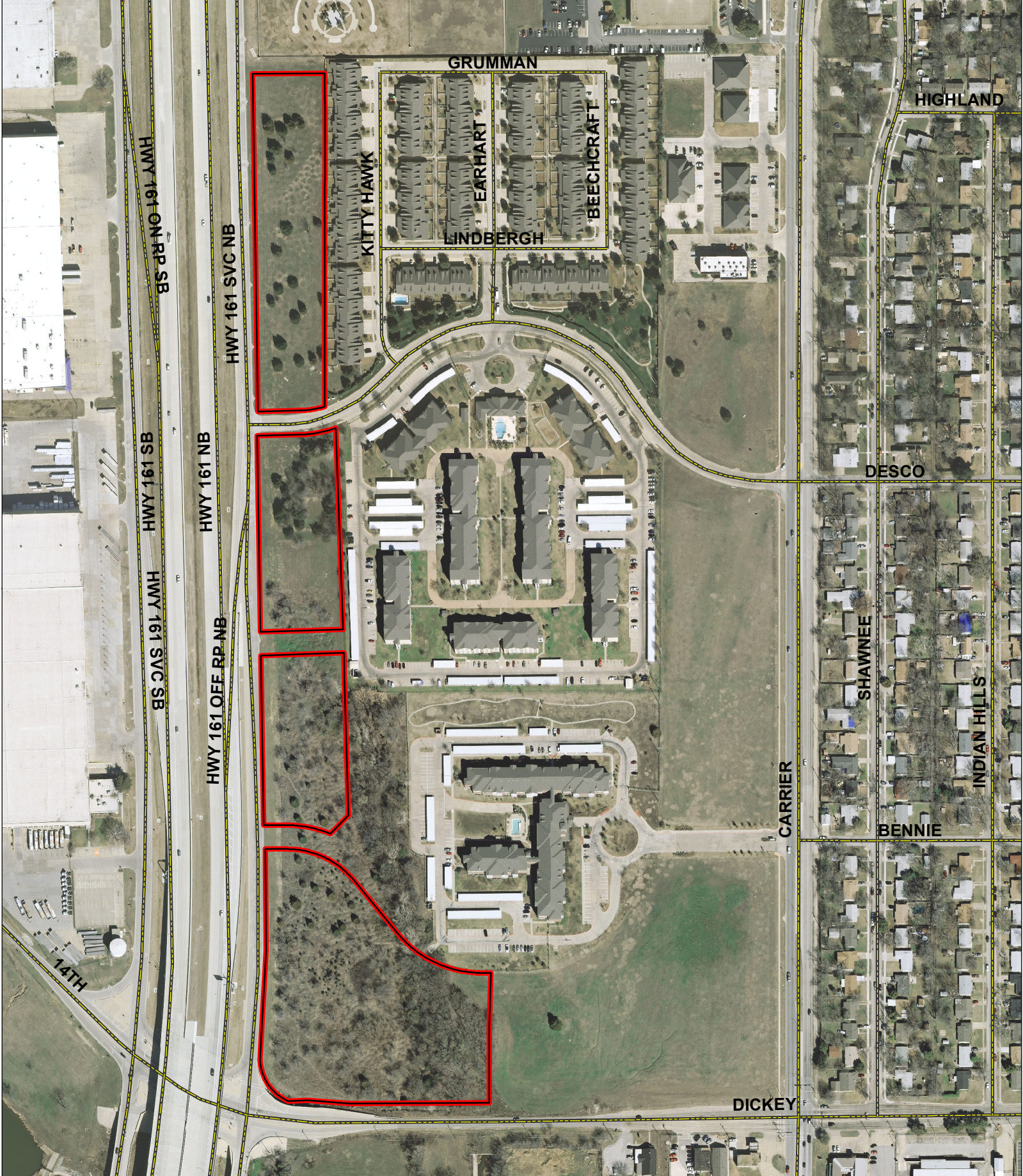






CASE LOCATION MAP

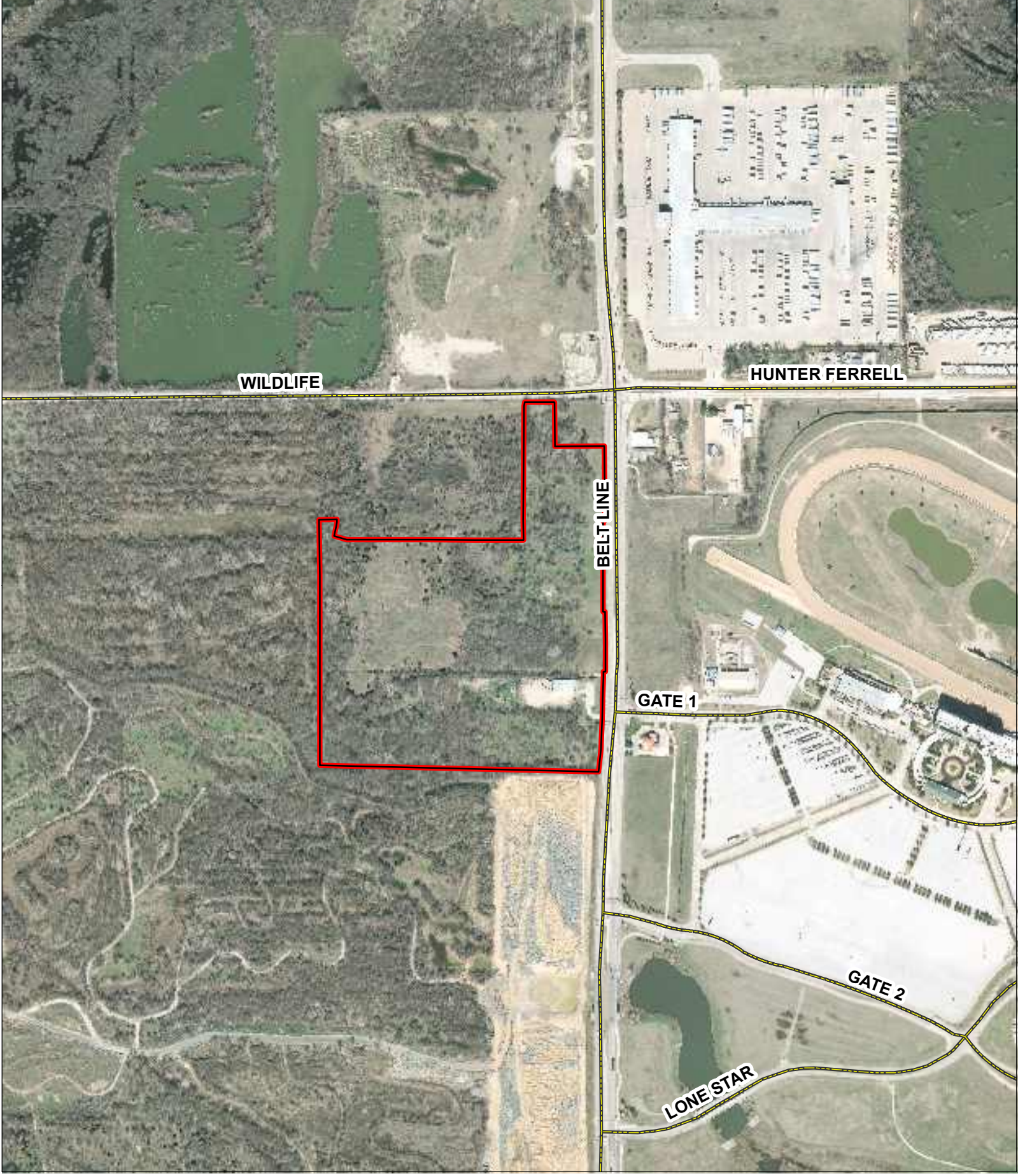

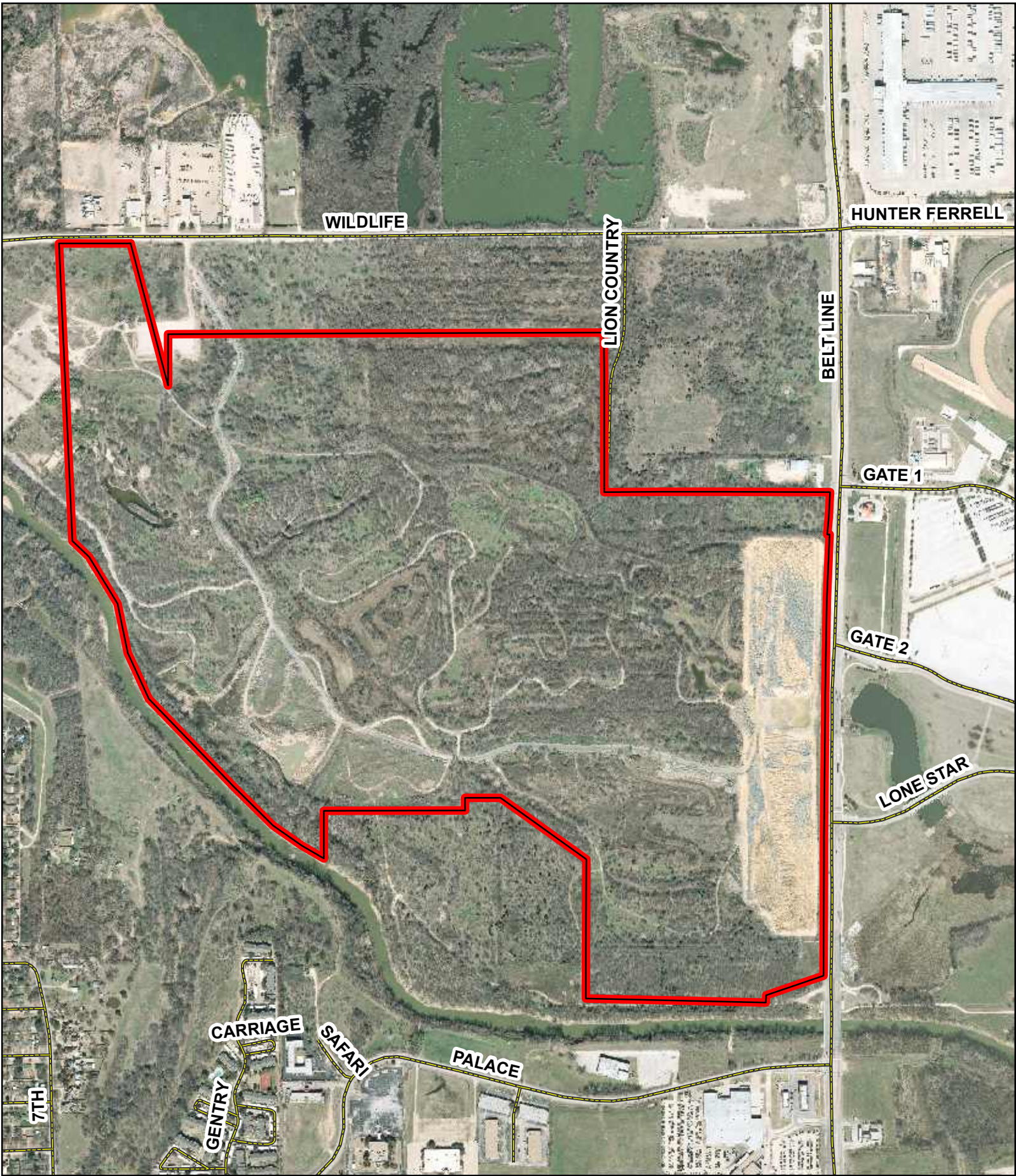

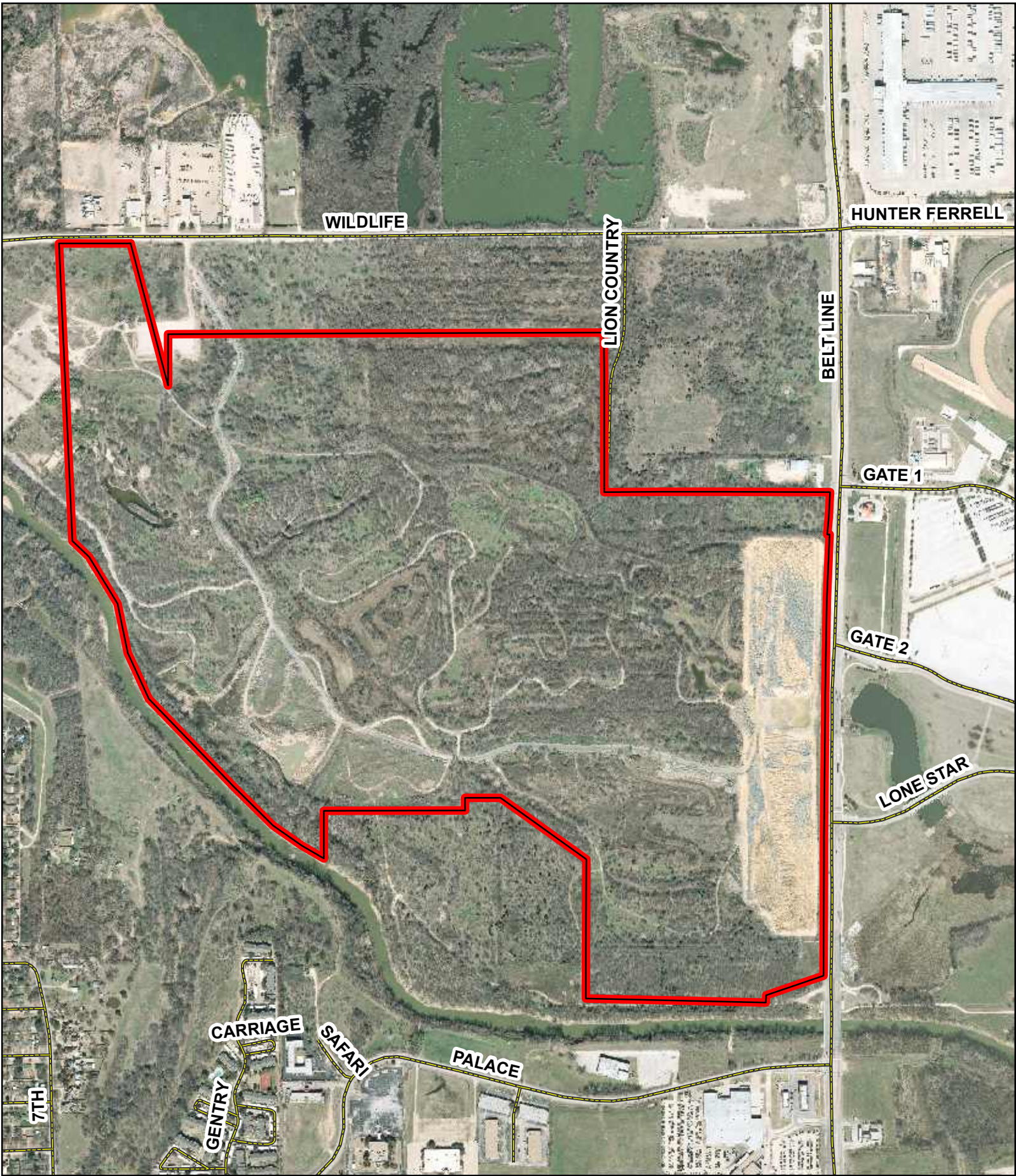
