AWARD CRITERIA

- 1 the purchase price
- 2 the reputation of the bidder and of the bidder's goods or services
- 3 the quality of the bidder's goods or services
- 4 the extent to which the goods or services meet the municipality's needs
- 5 the bidder's past relationship with the municipality
- 6 the impact on the ability of the municipality to comply with laws and rules relating to contracting with historically underutilized businesses and on-profit organizations employing persons with disabilities
- 7 the long-term cost to the municipality to acquire the bidder's goods or services and
- 8 any relevant criteria specifically listed in the request for bids or proposals
- *Each vendor is responsible for submitting all relevant, factual and correct information with his or her bid. The evaluation committee will assign a ranking score to each vendor based on the available data.

Discount 50 points

The bidder with the highest discount receives the maximum score.

The bidder with the next highest discount receives points based on dividing the next highest discount into the highest discount and multiplying that percentage by the available points. For example, assume 50% is the highest discount offer, then that bidder would receive 50 points (50/50=1.00x50=50). Assume 25% is the next highest discount offer, then that bidder would

receive 25 points (25/50=0.5 x50=25), etc.
