Call to Order

Mayor Jensen called the meeting to order at 4:30 p.m.

Code Enforcement - Update on Nuisance Abatement and Neighborhood Enrichment Team - Presented by Steve Collins

Steve Collins, Code Enforcement Manager, updated Council on recent improvements in his division. These improvements include one additional code enforcement officer; equipment upgrade; reduced area coverages; efficiency in property inspections, case development and citation effectiveness; reduced response time; and collaboration with the Police Department. Mr. Collins went over statistics for 2015 including: Code Cases 18,750; Violations 19,770; Complaints 4,224; and Citations 1,298. He explained Operation Clean Sweep where the department identifies properties in the city where there are numerous complaints and then focuses resources there. He stated this program has decreased the number of violations significantly. The Neighborhood Enrichment Team conducts investigations, nuisance abatements, demolitions and illegal operations.

Mayor Pro Tem Swafford commended the Code division and stated that the cooperation between Police and Code has helped to improve the community. Council Member Wooldridge stated Code does an amazing job and he expressed his appreciation for everything they do. Mr. Wooldridge asked how the amount of liens are arrived at. Mr. Collins replied that when staff cleans up the property the cost of labor and equipment is arrived at and the lien is placed in that amount. Council Member Copeland asked about the statistics that Mr. Collins quoted earlier in his presentation and which of those statistics he would most like to impact. Mr. Collins said the season dictates the number of complaints (i.e. a dry season vs. a rainy season when numbers are up). He said the economy also impacts code enforcement; for instance, if people are working they take care of their property, but high foreclosures mean more complaints and non-compliance. He said social media has also assisted with citizens making complaints. City Manager Tom Hart stated when the transition was made from Planning to Police, the staff was somewhat

apprehensive, but the Police Department has done a great job of collaborating with Code.

Prairie Lights Re-Cap - Presented by Beverly Grogan, Parks, Arts and Recreation Department

Beverly Grogan, Parks, Arts and Recreation, stated that the road in the park was flooded (under five feet of water) taking away access to many of the exciting Prairie Lights displays. However, the Streets and Parks Department built a road in two days but 25% of displays stayed in flood waters. The remaining 75% were all new displays. She said the VIP service had to be discontinued because the back gate stayed underwater. Ms. Grogan said there was not record attendance this year as in the past nine years. Prices had to be discounted because of the flooding but the event still grossed over \$1 million for the third year in a row. The Texas partner cities also experienced the significant rain events that Grand Prairie did but both cities made enough to continue the partnership. She said she has received inquiries from Los Angeles, New York, Missouri and Tennessee. Prairie Lights is the #2 attraction in the State (after the Riverwalk). Council Member Copeland asked how the attendance number of 164,000 is arrived at. Ms. Grogan said there is a formula for counting the crowd (i.e. cars and larger carriers). Council Member Giessner thanked Mayor Jensen for having "Cycling with the Mayor" at Prairie Lights.


Council Member Shotwell referred to Consent Agenda Item 13 (Water and Wastewater Improvements behind 321 W. Main) and asked if this work would be for all tenants along that line. Bill Crolley, Executive Director of Planning, replied that it would. Mr. Shotwell asked if the city would pay for those connections. Ron McCuller, Public Works Director, replied the city would pay for the connections. Mr. Crolley said these improvements should be completed by November 1. Council Member Shotwell asked if the businesses would be notified about this project (i.e. water turnoff, etc.). Mr. McCuller replied that the contractor normally notifies the tenants.

Council Member Shotwell referred to Consent Agenda Item #18 (Epic Project funding) and asked how much money was currently in the Capital Lending Reserve Fund. Mayor Pro Tem Swafford said there was around \$7-8 million before this amount comes out. Council Member Wooldridge referred to Consent Agenda Item #14 (traffic signal at Fire Station 10) and asked if this was only for the traffic signal at Balboa. Walter Shumac, Transportation Director, replied that it was only for Balboa but the other intersections in this area would be coming to council for approval at a later date. Deputy Mayor Pro Tem Clemson asked about the huge range in bids on Item #9 (tree and brush services) from \$79,800 to \$399,000. Robert Myers, Purchasing Managers, said that was correct.

Executive Session

Mayor Jensen convened a closed session at 5:15 p.m. pursuant to Chapter 551, Subchapter D of the Government Code, V.T.C.A., to discuss Section 551.072 "Deliberation Regarding Real Property" and Section 551.087 "Deliberations Regarding Economic Development Negotiations." The closed session was adjourned at 5:45 p.m.

Public Hearing on Zoning Applications

SU160203 - Specific Use Permit - Gemini Coatings (City Council District 1). Approve a specific use permit to operate a hazardous industrial use. The 4.28-acre property, located at 2350 114th Street is zoned Light Industrial (LI) district. The applicant is Maxwell Fisher, Masterplan Consultants and the owner is Jason Melton, Gemini. (On February 1, 2016, the Planning and Zoning Commission recommended approval of this request by a vote of 9-0).

Mr. Hinderaker stated that Gemini coatings make stains for wood projects. He said there are some chemicals used in this process that are hazardous materials which requires an SUP. He stated there were no appeals equested.

Maxwell Fisher, Masterplan, 900 Jackson Street, Suite 640, Dallas, 75202, stated he was representing Gemini, and they were complying with all environmental and safety codes. There were no questions from the Council.

SU160204 - Specific Use Permit - Advanced Modern Performance (City Council District 1). Approve a Specific Use Permit permitting the operation of a specialty high-performance automotive modification shop primarily engaged in upgrading engines of late model performance style GM vehicles. The approximately 1-acre property, zoned Light Industrial (LI) District and located within the S. H. 161 Corridor Overlay District, is addressed as 247 Gilbert Circle, Suite A. The property is generally located west of Gilbert Circle and approximately 1/2 mile north of W. Shady Grove Road. The applicant is Bryan Pomeroy, AMP LLC and the owner is Larry Causey. (On February 1, 2016, the Planning and Zoning Commission recommended approval of this request by a vote of 9-0).

Mr. Hinderaker stated this case was for a high performance modification shop specializing in modifying later model GM vehicles. He said the applicant will be occupying the eastern end of the existing building and there would be no outside storage. Mr. Hinderaker said the applicant requested an appeal for a masonry wall.

He said the applicants want to erect a wood fence 30' from the property line on Gilbert Circle and staff is supportive of the wood fence.

Bryan Pomeroy, 247 Gilbert Circle, stated he was one of the applicants and was present to answer questions. Council did not have any questions.

Deputy Mayor Pro Tem Clemson moved, seconded by Mayor Pro Tem Swafford, to close the public hearing and approve Case SU160204 as presented by staff and as recommended by the Planning and Zoning Commission. The motion carried unanimously.
