On May 5, 2005, a compliance investigation of the above referenced facility sanitary sewer collection system was conducted, in which sanitary sewer overflows (SSOs) were documented. Based on the findings of the investigation, your facility was selected to participate in the SSO Initiative, which is intended to assist municipalities with addressing SSOs that might escalate to such a degree as to cause a negative impact on human health and/or the environment. The initial agreement expired on December 31, 2016 and the City has requested to reenter the program. Additionally, the City has reported 34 SSOs from the collection system since the agreement expired. Participation in this outreach initiative is entirely voluntary. We have provided you more detailed information about the SSO Initiative (SSO Initiative: Information for Prospective Participants (GI 389)). If you would like to schedule a meeting to discuss the SSO Initiative, please contact the DFW Region Office within 14 days.

Should you choose to participate in the SSO Initiative, you will be required to sign and submit a Notice of Intent to Participate in the SSO Initiative form (also enclosed) to the DFW Region Office within 30 days of the date of this letter. If we do not hear from you within 30 days, the offer to participate in the SSO Initiative will be rescinded, and a Notice of Violation (NOV) will be issued for the documented SSOs.
