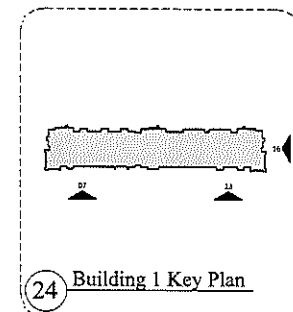
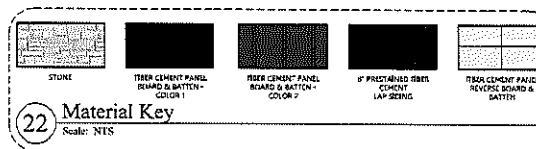


07 Building 1 - South Elevation

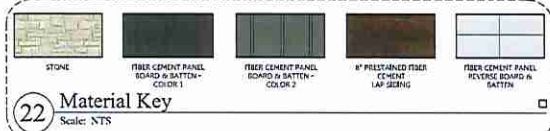
BUILDING 3 - ELEVATIONS

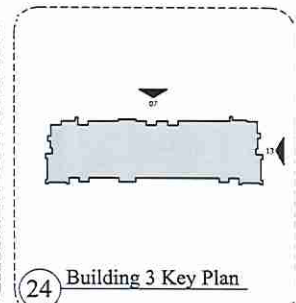
13 Building 3 - North Elevation

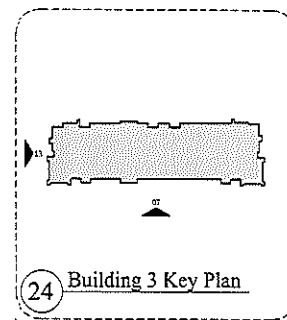
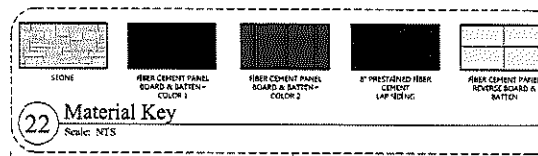
07 Building 3 - East Elevation

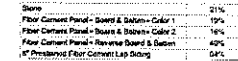

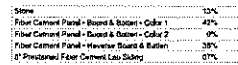

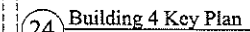
07 Building 4 - South Elevation

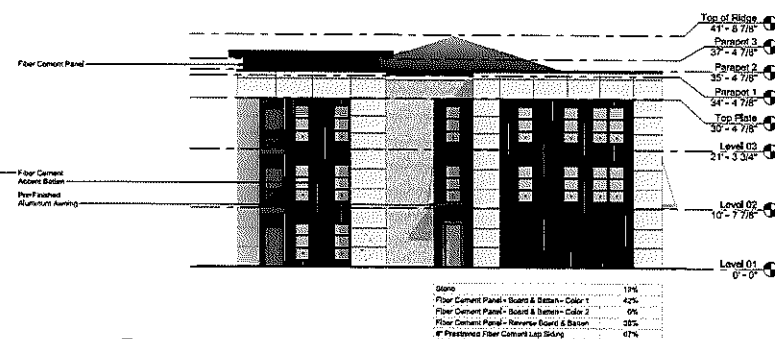
02 Building 6 - Overall East Elevation

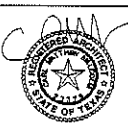


16 Building 6 - South Elevation
