### **Operational Plan**

Champion Collision Repair Center will be serving the community as a collision repair center on a daily basis, Monday through Saturday from 7:00 a.m. to 5:00 p.m. All our business will be conducted with walk-in-customers and insurance companies as such we will not be repairing buses nor trucks, nor even heavy duty equipment. All of our work will be focused on small automotive cars as well as vans. We would not be rebuilding cars, or buying and selling, or acting as a wholesaler, we would be a collision repair center only. The clientele we would serve would therefore consist of walk-in-customers and insurance companies.

Champion Collision Repair Center will be operating with, one office administrator, two collision repair technicians, and one auto painting technician. As a result of our limited space and manpower, we would only be capable of repairing five cars at a time and therefore five cars would be our facility's operating limit. At the same time there will be three to four cars parked inside the storage facility awaiting inspection by an insurance agent, as a result all cars dropped off by customers will be housed indoors.

Employee and customer parking will be at the front of the building and will consist of four parking spaces for employees and five for customers at all times. Our parking will be enough for our operation both inside and outside of our establishment. Because of the fact that we are a small operation we do not require a large parking lot, nor would we intentionally overwhelm ourselves with more cars than we could handle, as such we respectfully ask the City of Grand Prairie to accept our operation plan with concern to the parking.

All parts that are being replaced throughout the repair process will be stored inside a recycling bin located inside the building; this container will be emptied on a weekly basis through CMC Recycling, a licensed scrap metal recycling company. Similarly, we will store all fluid waste in a moderately sized 55 gallon drum and it will be disposed of on a monthly basis by H&H Oil Recycling, a licensed oil disposal company.

All of our materials and paints will be stored in a fire proof storage cabinet and the paint will be stored in a paint mixing room, equipped with a fire prevention and extinguishing system approved by the city.
