### Historical Summary of 1629 E Main St – HDA Auto Sales

June 7, 2000 – CO #00-2780 approved for Car Sales, Body Shop, and Mechanic Shop

February 12, 2004 – Inspection conducted

**Citation** issued for discharges of vehicle fluids on the ground and for mosquito harborage

**NOV** issued for failure to provide air authorization, oil spills on the ground, tires w/o rims outside

Notes: operator is salvaging, stripping cars, outside storage of parts, washing without a wash bay, RPZ, and sand grit trap

March 8, 2004 – Reinspection conducted

Notes: oil spills removed but now a green liquid is on the ground, tires inside trailer will be taken to landfill, outside storage of junk cars, vehicle washing

March 11, 2004 – Received Building Project Review #04-1564 for a paint booth

November 9, 2006 – Inspection conducted

**NOV** issued for failure to store liquid wastes properly, discharges of vehicle washing, and outside storage of tires w/o rims

Notes: Operator is washing without a wash bay, failure to provide waste manifests, no waste containers onsite, operator not using a licensed waste hauler, trash

January 9, 2007 – Reinspection conducted

Notes: trash, standing water, outside storage of parts, outside storage of tires w/o rims, open containers outside (10-15 drums), illegal paint booth

January 16, 2007 – Received Building Project Review #07-238 for fire system in paint booth

March 5, 2007 – CO #07-1464 applied for paint booth; approved 3/12/07

March 5, 2007 – Reinspection/CO Inspection conducted

Notes: Trash removal is ongoing but all other issued from January inspection corrected

August 7, 2008 – Inspection conducted

**NOV** issued for washing with chemical, no RPZ, sanding activities outside, dumpster lid not closed, outside storage of tires w/o rims, gas cylinders not secure

October 15, 2009 – Inspection conducted

Notes: relabeling of waste containers was necessary, discharges of vehicle fluids on the ground under the car port need to be removed, fax copy of waste manifests to office

May 11, 2010 – Inspection conducted

**NOV** issued for discharges of vehicle fluids on the ground, outside storage of open chemicals, lid on dumpster open, no waste manifest available, washing, power washer onsite, no RPZ, need to review air authorization documents

May 13, 2010 – Reinspection conducted

Notes: Inspector noted that car washing materials were stored outside, open containers were outside, manifests for used oil only (not for other wastes), no waste container for used bondo, air authorization not verified; discharges of vehicle fluids on the ground, do not allow absorbents to accumulate on the ground, provide waste containers for flammable liquids

September 29, 2011 – Inspection conducted

**NOV** issued for trash, discharges of vehicle fluids on the ground, discharges of sanding materials outside, outside storage of parts

Notes: tires w/o rims stored outside, dumpster lid not closed, not all waste containers labeled

October 26, 2011 – Reinspection conducted; all previous issues corrected

August 30, 2012 – Inspection conducted

Notes: Filters in paint booth are missing

July 16, 2013 – Inspection conducted

**NOV** issued for trash, labeling, open containers stored outside, outside storage of batteries, outside storage of parts, gas cylinders not secure

July 31, 2013 – Reinspection conducted; all previous issues corrected

July 24, 2014 – Inspection conducted; no issues notes

June 16, 2015 - Inspection conducted

**NOV** issued for trash, vehicle washing, labeling, outside storage of tires w/o rims

Notes: Provide and label waste container "Hazardous Waste Used Bondo & Date", Provide and label waste container "Universal Waste Paint Waste & Date", Label waste container "Used Absorbent" Remove trash throughout property along fences, Cease vehicle washing, All tires w/o rims under the awning must be placed inside the building or removed, Replace all filters in the paint booth

July 7, 2015 - Reinspection conducted; no corrections

July 14, 2015 - Reinspection conducted; no corrections

**Citation** issued for trash, labeling and outside storage of tires w/o rims
