Call to Order

Mayor Jensen called the meeting to order at 4:30 p.m.

Police Chief Update - Presented by Chief Steve Dye

Chief Dye updated the Council on his recent FBI trip to Scotland as the only North Texas Chief to attend and only one of 14 nationwide. He said Australia, Canada, England, and the US share counter terrorism intelligence and best practices. There will also be a meeting in Quantico at which all the ountry representatives will be attending. Chief Dye said he will be sharing the information from the meeting with area chiefs. He said that many times terrorists are found at the local level. Counter terrorism and cyber-crime are two areas that are adding to an already complex list of crimes that local departments have to deal with. He emphasized that terrorists are increasingly become home grown.

Tom Hart, City Manager, said he was impressed with the new recruit class. Chief Dye said he was proud of this class which is the largest ever with 24 recruits. He said the environment, attitude and benefits provided to our officers draws bright college students to our city, plus five local laterals from other departments and two from out of state. Council Member Copeland asked if these recruits are part of the 40 new officers. Chief Dye said that most are replacing retirements; 15 are filling General Fund slots and nine will be filling Crime Tax slots. Chief Dye said the November class will have 5-10 recruits. He said there were 227 officers when he started with the city and there are now 252; next year there will be 267. Council Member Copeland suggested putting this information in the Pipeline. Council Member Wooldridge asked how many laterals were in this class. Chief Dye said the lateral class is 8 weeks and there are 5 instate who will go through the academy and 2 out of state laterals will be part of the basic class.

TCAP Demand Response Program - Presented by Andy White, Assistant to the City Manager

Andy White, Assistant to the City Manager, updated Council on the TCAP Demand Response Program. He said Grand Prairie has qualified for two programs: 4CP (critical peaks from June – September) and the Economic Demand Response (only the police building qualifies). He said the program which is strictly voluntary, allows commercial customers to reduce their energy bills. In the 4CP, if you can reduce consumption during a 15 minute time period, this will be reflected in savings on the city's energy bill. There are three pump stations that qualify. Mr. Hart said he thought it was worth a try.

Agenda Review

Mayor Jensen referred to Item 17 (Appointments to the Crime Control and Prevention Board) and stated that the Mayor and Mayor Pro Tem have historically not been on the board and he would like to continue with that which would mean removing Mr. Fregoe and adding Council Members Thorn and Copeland. He added he would like to elect Mr. Fregoe as Mayor Pro Tem and Mr. Shotwell as Deputy Mayor Pro Tem.

Mayor Jensen referred to Item 18 (Appointments to the Sports Corporation) and said that his reappointment would only require a majority vote, but according to rules adopted a few years ago, Council Member Swafford's appointment would require a 3/4 vote. Mayor Jensen said the positions of Mayor and Chairman of the Finance and Government Committee should always be on the Sports Corporation and the Mayor should always be President.

Council Member Swafford said that Item 10 (Right-of-Way Mowing) was recommended for approval by the Finance and Government Committee but he had asked Mr. Herold to provide the bid tabulation and he had received the summary of bids.

Council Member Copeland asked for clarification on Item 12 (Interlocal Agreement with the Town of Addison). Mr. Postell said this was a typical agreement so that city can piggyback onto other cities who have already bid items.

Council Member Shotwell referred to Item 8 (Sale of Tax Foreclosure Properties) and asked how the minimum bid is set. Mr. Crolley said \$2000 is what is being used for most properties, but no appraisals are being done. Council Member Shotwell said minimum bids on some are low and asked Mr. Crolley to look into how the minimum bids are set. Council Member Shotwell asked Mr. Herold if the repairs to the Bowles Parking lot involved the whole lot (Item 15). Mr. Herold said it was only the portion by the pool.

Executive Session

Mayor Jensen convened a closed session pursuant to Chapter 551, Subchapter D of the Government Code, V.T.C.A., Section 551.074 "Personnel Matters" Cause No. 86538 City of Grand Prairie v. Thomas L. Mendenhall; and Section 551.087 "Deliberations Regarding Economic Development Negotiations." The executive session was adjourned at 5:40 p.m.

Citizen Comments

Thomas Varacky, 2050 Lasalle Trail, said his neighborhood is part of the Lake Parks PID. He said he would be leaving Grand Prairie to move to Florida. Mr. Varacky thanked Mayor Jensen for his help when he served as Council Member, District 6 and Council Member Wooldridge as well. He said he appreciated assistance from Bill Crolley, Planning Director, Lee Harriss, Special District Administrator, and Steve Collins, Code Department Manager. However, he said the neighborhood has gone through a drastic change. There are now vacant homes, unkempt lawns, and expired stickers on cars. Mr. Varacky said there seems to be some question as to who is responsible for these issues. He added that cars are blocking the sidewalk. Mr. Varacky asked for help from Code Enforcement with junk cars with invalid stickers. He said Code needs to make more trips through the neighborhood and perhaps an intern program could be set up to augment the Code Department staff.
