Proposals were received on October 15, 2015, for the City of Grand Prairie RFB #15156 for the interior coating of the Small Hill Elevated Storage Tank. A bid tabulation is enclosed with this letter for your use.

The low bid was \$83,128.00 by Tank Pro, Inc. of Northport, AL. In reviewing the bid documents, it was determined the coating system proposed by Tank Pro, Inc. does not meet the project specifications. Tank Pro choose to use a portion of the Tnemec system specified in the specifications but not the complete system. The system chosen by Tank Pro, Inc. results in a finished coating thickness of 12-14 mils. The finished coating thickness as stated in the project specifications is a minimum on 20 mils.

The second low bid was by Champion Coatings, Inc. from Savage MN of \$108,900.00. Champion Coatings chose to provide the Sherwin Williams coating specified in the project specifications. Greg Holman and myself have checked several of the contractor's references and have found the contractor is capable of providing the City with a professional and quality iob.

We recommend the award to Champion Coatings, Inc. of Savage MN, for the total amount of \$108,900.00.
