Bid Results

Bids for the referenced project were received and opened publicly on September 27, 2016 at the City of Grand Prairie. A total of four (4) bids were received. The table below is a summary of the detailed bid tabulation.

^{*}Note: Section 1:Item #11 of the Atkins Brothers Equipment Company, Inc. bid did not include \$0.60 within the extended price column and was rounded down. The price shown above corrects this error.

The total adjusted Engineer's Opinion of Probable Cost (adjusted for amended items) was \$754,461.05. The lowest bid received was from Reytech Services, LLC with a total amount of \$673,916.27 and 120 days to complete the project. The bid tab associated with this bid has been reviewed for accuracy and omissions with one error found. This error is noted above and did not materially affect the low bid.

Contractor Qualifications

We have received and reviewed qualifications, financial statements, and company profile information from Reytech. Within the bid package, Reytech Services, LLC, provided a list of municipal references for past and ongoing projects. MULTATECH has contacted 3 of these references and has confirmed their positive interaction with Reytech on their respective projects. Contacts noted that the work performed by Reytech was of good quality, that Reytech was responsive to changes, that they performed within budget and schedule constraints, and that the projects overall went smoothly. One contact commented that Reytech had initiated some change orders for one of their projects, and that the work was justified and the change order amount was very reasonable for the change of scope. No negative feedback was received.
