- 2. Legislative Priorities: Megan: Went over them in F&G. Swafford: in F&G, after reviewing resolution, felt what is being opposed is even more important than what is being proposed. Mayor: whoever is chosen as Speaker of the House will be very important. May need to propose compromises on the tax cap (i.e. 3-year rolling average). Swafford: need to go to Austin with proposals. Copeland: is there a need to try to impact who is chosen as speaker (i.e. TML, COG, etc.). Jensen: cities of TML line up behind a moderate speaker.
- 3. Anna Doll, went over the proposed Annual Budget F&G has spent numerous hours going over the Budget. Swafford: staff has done a great job putting the budget together and showing alternatives. Doll: August 23 is budget workshop. Gen Fund Revenue \$135,552047. Cert. taxable property values: \$13,521607,208. Tax Rate remains the same of \$.669998 per \$100 valuation. Total Estimated Tax Rev \$96,713,696. Proposed Expenditures are \$134,406,918. 5% Step; Comp Plan 3%; Funding 17FT; 14 PT; added 12 FT converting 5PT to full-time; 20 year TMRS (currently at 25-year).

Increase 4.5% increase in water/wastewater fund; storm drainage fees 3% increase; Solid Waste 1.59% increase per household per month

Swafford: 20 year TMRS have talked about this and what other cities have it. It is an asset to cities to have it to attract top talent.

4. Epic Waters – Rick Coleman, American Resort Management

250,000 admissions through the door; over 65% outside GP; 80% of visitation is new visitors; 48% come because of word of mouth; guests have come from over 46 states and 6 countries. 84% answered they would visit again; 84.3% would recommend to friends; 83.8% is overall satisfaction.

Yakesch: went over the annual budget and year-end projections. \$1.6 net profit at end of year. Mayor: Self-funded except debt. Mr. Coleman went over the upcoming programs from August to the Christmas Holidays. Coleman: 80% new visitors, when does that number decline? Coleman: 70% next year and 60% year after. Opeland: completion on wave pool? Coleman: labor day. Four hotel partners on the website and on weekends they are generating 100 rooms per night.
